Diapering station in the toddler area with dedicated sink from 3 compartment sink and inside washroom.

Chlorine test strips located in staff kitchen.

Dishwasher is not in use for tov washing.

3 compartment sink located in the toddler area for toy washing. Air drying of toys occur on children's table on drying mats which get laundered after.

Sick policy discussed.

All hand washing station maximum hot water temperatures were measured between 46-48 degrees Celsius (satisfactory).

#### 2.1 04. Are clients at this facility being protected from hazards (Non-Critical)?

Description: Various equipment such as scissors, bleach water disinfectant, ziplock bags, marbles, tin foil boxes were stored in a manner that were accessible to children in the toddler area and the common area that is used by the preschoolers for lunch.

#### 3.1 06. Are proper protocols being followed in regards to client care?

Description: The bleach water disinfectant for the toddler diapering station did not have bleach concentration detected.

\*\*Ensure the bleach water disinfectant is maintained at a concentration of 100 ppm. Mix 1/2 to 1 teaspoon of household unscented bleach to 1 litre of water.

**DIAPERING - DISINFECTING** 

Disinfecting of diapering surfaces is not being performed properly in this social care facility. In every social care facility where diaper changing is performed, diaper changing surfaces shall be wiped using an approved disinfection solution. Approved disinfectants include 100 ppm chlorine, 0.5% accelerated hydrogen peroxide or another disinfectant approved by the Executive Officer. AR 143/81 s 30

As a gentle reminder, ensure laundry facility is locked when not in use and reorganize supplies/equipment so that they do not pose a hazard to the different age groups.

Target Completion Date: 2025-01-03 SURFACE FALL ZONE (CRITICAL)

The surface under and within the safe fall zones of elevated play equipment is unsatisfactory. The surface shall be loose fill material such as pea gravel, sand, wood chips, wood mulch, or a unitary manufactured surface such as rubber tile, rubber pour-in place, or other approved material adequate for the equipment and fall height. The surface must conform to CSA requirements. AR 143/81 s 6, 24 & 25, AR 243/2003 s 2
